Further work is needed to analyse the nature and content of SMRs/HERs. We are considering the best way to update this data.

HS schedules these under the terms of the Ancient Monuments and Archaeological Areas Act 1979. The number of SMs changes over time, reflecting the strategic scheduling programme. Of this, since 2005 the area programme has considered 95 out of 894 parishes in Scotland and completed proposals arising out of 53 parishes. The

Work is ongoing to improve the quality of this dataset.  There are no available, robust and nationally consistent approaches to assessing the condition/risk of other HE assets. Over time, HS will explore the feasibility of developing indicators for the condition of and risk to other HE assets – and suitable approaches to data gathering.
