## Supporting information guidance

- Images must be taken from public land or public rights of way, or you must have the permission of the landowner.
- Images must be yours or, if a historic image, you must have the rights to it.
- Do not include information in images which can be used to identify an individual avoid people and faces in images. Do not include car registration plates (or if you do, blur them out).
- Do not include supporting information that includes personal or sensitive information.

## What happens now?

Once you have filled in your form, **save it to your computer** and then email it to us at <u>designations@hes.scot</u>. We do not accept applications sent by post. Please remember to attach any supporting information. Your email must not be more than 20Mb. We will acknowledge your application within five working days. We will first assess your application to see how best to deal with your request. If we go ahead with your application, we may take up to six to nine months before reaching a decision. If we decide not to go ahead, we will let you know as soon as possible.
